<u>OLD BUSINESS</u>- The Ohio Department of Transportation (ODOT) has offered a 2 year maintenance agreement to the village. The agreement would include durapatching of asphalt in areas not requiring resurfacing, concrete repairs of the longitudinal cracking, and misc. routine maintenance as identified by ODOT crews. (information sheet attached) Riffle made a motion to support Kruse's recommendation by moving forward, and entering into, a maintenance agreement with ODOT, Dunn second. - ➤ WATER DEPT: Preparing for the Ohio EPA Sanitary Survey on May 11.
 - > SEWER DEPT: The new curtain for the lagoon at the Waste Water Treatment Plant has been delay due to the rain event.
 - > STREET DEPT: Will meet with ODOT traffic engineers to discuss the existing 20 MPH lights and all US 20 signs. ODOT is taking over the 20MPH lights in the school zones.
 - > OTHER: 1. Attended an Ohio Rural Community Assistance Program (RCAP) 2 day seminar in Findlay. Obtained a lot of valuable programs and templates to aid us with meeting upcoming OEPA requirements.
 - 2. ODOT has been informed about the condition of the Anderson Rd. sign.
 - 3. Our current ODOT contact, Kacey Smith has been promoted.

ODOT AGREEMENT INFORMATION

2017/2018 = \$23,515.09

2018/2019 = \$31,353.46

(Org. agreement costs would have = \$35,272.64 - 2yrs.)

- ✓ Typically only offer 2 year agreements. The 3 year agreement was generated specifically for us to ease the cost of their estimated costs of \$70,545.28 for all the needed repairs & maintenance.
- ✓ Above prices are the original terms: Additional years costs will go down.
- ✓ Pending resurfacing of US 20 2021: After resurfacing the cost of an agreement would be considerably less.
- √ Village WILL be included in determining areas of concern

Maintenance:

- 1. Durapatching of asphalt in areas not requiring resurfacing.
- 2. Concrete repairs of the longitudinal cracking
- 3. Misc. routine maintenance as identified by ODOT crews

The paving train will be in the county late May to mid-June and this would be the time for the major asphalt repairs and resurfacing to take place. An agreement must be in place to utilize this service.

 **Kacey is verifying that SR 105 is included in the agreement. I stressed the fact that this is a must!
 - 2. The cost for us to have US 20 resurfaced from the RR tracks (EB outside lane) to Bridge, an area of 35' x 60' in front of Solomon, longitudinal asphalt seams filled, plus numerous potholes filled, by our contractor would be \$32,600.00. This does not include the bridge expansion joint or any concrete repairs.
