

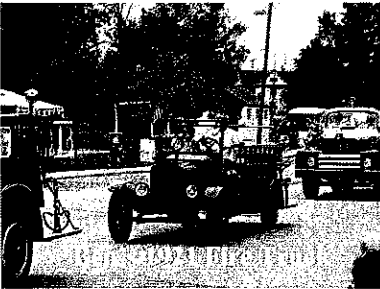

FROM THE MAYOR - RICH HARMAN

- ◆ Congratulations 4th of July, Inc. on another successful celebration, parade and impressive fireworks display. It's nice to see such dedication and enthusiasm by a great group of volunteers, working hard to keep a Village tradition alive.
- ◆ Council is exploring the possibility of expanding the Administration Building on Lime Street to include the Village Clerk, Billing Clerk and a new Council Chambers. We are currently working with Poggemeyer Design Group of Bowling

Green to determine the feasibility of the project.

- ◆ In May the Village utilities consultant, John Courtney of Courtney & Associates presented the annual rate review for the Water, Sewer and Electric funds. Mr. Courtney informed Council that at this time the Sewer and Electric funds are operating efficiently, however the Water fund revenues will need to increase in the near future. The water rates have not been increased since 1986 and due to the condition and unexpected maintenance of



the wells; it has created a hardship on this fund. Water rates will increase by 10% starting with the July usage.

ODOT Orange Barrel Update

According to ODOT, sidewalk and pavement repairs will be finished up in September within the Village. Beginning July 22, US 23 will be closed for 60 days and will not be accessible from US 20 as preparations are being made for the 1st course of asphalt on the eastbound lane from Bradner Road to the west edge of Woodville. The top course of asphalt is in the schedule for the end of September, that will complete the project from Woodville to the new 420 interchange. According to Mark Mondora, project manager for ODOT, it looks like a final completion date may be one month earlier than the original November 2009 date. All work is weather permitting.

FROM THE ADMINISTRATOR - BOB RICKARD

Woodville's Sewer Separation project is in the final stages of design with plans to be submitted to the Ohio Environmental Protection Agency the first week of August. After OEPA approval of the final design plans the Village will advertise for the receipt of bids to construct the project, hopefully in October of this year. Village representatives will be continuing with field investigations throughout Woodville through October as bid details are finalized.

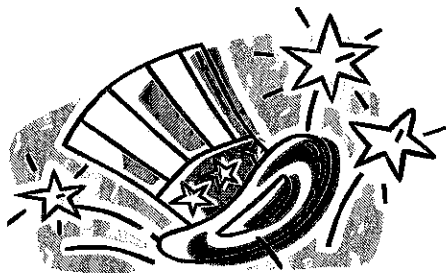
Village Council continues to pursue other grant funding sources to supplement nearly \$750,000 in grants allocated for the project by the Ohio Public Works Commission. Council recently submitted a request for federal grant funding to Congressman Robert Latta which was then forwarded to the Congressional Budget Committee with his recommendation for funding assistance in the amount of \$2,000,000. The Village has also qualified for a 0% interest loan for the project from

OEPA. Pending OEPA approval, and compliance with grant program requirements, the Village anticipates that construction could begin as early as January or February, 2010.

The Club celebrated with a luncheon and entertainment by the Book Guild Poetry Group.

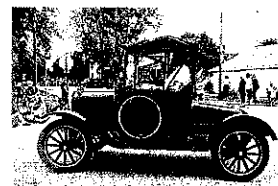

FLOOD LOSS MITIGATION PROJECT

The Village is working with Sandusky County Emergency Management Agency on the Flood Loss Mitigation Project.

At the request of a property owner who has had repetitive flood losses to a residential property in the Portage River Flood Plain, the Village of Woodville Flood Plain Administrator (and Zoning Inspector) Bill Rowles is working with Chris Mock, the Director of Sandusky

County EMA, to investigate and apply for Federal funding to assist residents faced with this problem.

The Federal Flood Mitigation Assistance Program (FFMA) exists to reduce or eliminate claims under the National Flood Insurance Program (NFIP). Between June of 2009 and June of 2013, repetitive loss structures in the flood

plain will be identified, corrective actions specified and corrective measures implemented if funding is obtained from FEMA for up to 75% of project cost.

If any village property owner has a residence in the flood plain and concerns about repetitive losses, contact Barb Runion at Town Hall for more information on this project.
