

## ORDINANCE #29 - 2010

### AN ORDINANCE MODIFYING THE WATER RATES OF THE VILLAGE OF WOODVILLE, SANDUSKY COUNTY, OHIO

WHEREAS, the Village has retained Courtney & Associates, Public Utility Consultants, to prepare an analysis of the projected revenues and revenue requirements for the Village's Water Fund; and

WHEREAS, based on that analysis, Courtney & Associates has recommended increasing the Village's water rates by approximately 20% in order to meet the projected revenue requirements; and

WHEREAS, the Council of the Village of Woodville, Sandusky County, Ohio concurs with Courtney & Associates' recommendation regarding the Village's water rates;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Woodville, Sandusky County, Ohio that:

SECTION 1: Effective December 1, 2010 Section 921.02 (a) (1) of the Village of Woodville codified ordinances is hereby amended to read as follows:

(1) The water rates and charges effective with bills rendered on or after December 1, 2010 until otherwise provided, shall be as follows:

<u>Usage (Gallons)</u>	<u>Residential</u>	<u>Non-Residential</u>
First 2,000	\$13.75 (Minimum)	\$16.20 (Minimum)
Next 8,000	8.90/1,000 gal.	12.70/1,000 gal.
Next 90,000	7.90/1,000 gal.	7.20/1,000 gal.
Over 100,000	7.90/1,000 gal.	3.45/1,000 gal.

SECTION 2: Effective June 1, 2011 Section 921.02 (a) (1) of the Village of Woodville codified ordinances is hereby amended to read as follows:

(1) The water rates and charges effective with bills rendered on or after June 1, 2011 until otherwise provided, shall be as follows:

<u>Usage (Gallons)</u>	<u>Residential</u>	<u>Non-Residential</u>
First 2,000	\$15.00 (Minimum)	\$17.60 (Minimum)
Next 8,000	9.75/1,000 gal.	13.95/1,000 gal.
Next 90,000	8.60/1,000 gal.	7.90/1,000 gal.
Over 100,000	8.60/1,000 gal.	3.80/1,000 gal.

(b) The rates and charges set forth in subsection (a) hereof are hereby established and the Village Administrator is hereby authorized to make and collect such rates and charges in accordance with the procedures set forth herein.

SECTION 3: Any part of any ordinance conflicting with the rates set forth above is hereby expressly repealed.

SECTION 4: All formal actions of the Council of the Village of Woodville, Sandusky County, Ohio concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and all deliberations of the Council that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
