WOODVILLE VILLAGE COUNCIL – REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday January 27, 2025 in Council Chambers 530 Lime St. at 7:00pm. Present at Roll Call: Mayor Ty Tracy. Council Members- Patrick Dunn, Denny Fetzer, Kelly O'Connor, Earl Ransom, Joe Riffle, and Tammi Throop. Administration: Village Administrator Tom Brickley, Chief Steve Gilkerson Solicitor Bob Kuhlman. Fiscal Officer Barb Runion was absent. Kelly O'Connor took the minutes. Audience: Mark Avers, Linda Knudsen.

Mayor Tracy called the meeting to order and led the Pledge to the Flag.

Minutes of the Finance Committee and Regular Council meetings on January 13, 2025 were approved as presented.

AUDIENCE PARTICIPATION – Mark Avers questioned electric meters 3 of 6 are minimum usage only, with smart meters they are reading something and there should not be anything to read. Mark will meet with VA Brickley to discuss the meter readings. Mark also questioned the income tax information; he was not able to attend the town hall meetings. Linda Knudsen stated that her meter was changed but the contractor would not drill through the concrete wall in her basement. She requested a second visit to see if that installation could not be completed with that being done. VA Brickley will contact Vanguard to schedule another visit. RECREATION & PARKS DEVELOPMENT – N/A Mayor Tracy asked if he attended the 4th of July Committee meeting on January 21 at the Library – 7:00pm, he did and stated they are moving the meetings to Tuesday due to Monday having conflicts with many members. Next meeting is February 11th. Fetzer questioned the pool and Ransom said the Committee will begin discussions for the upcoming pool season in February or March.

ADMINISTRATOR – Brickley reported:

- **WATER PLANT(WTP)**: Advertise for Water Tower February – April. Bid opening scheduled for May 15th at 10:00am. Contract after July 1, 2025 per OPWC conditions.
- **SEWER PLANT**: Requesting PTI date change to 12/1/2024 to 3/1/2025, advertise in May 2025.
- **ELECTRIC DEPARTMENT**: Substation maintenance P/M scheduled week of Jan. 27th – 31st.
- **STREET DEPARTMENT**: Replace 3rd plow (Water/Sewer operator's truck) 2008 truck, plow is rusted out. Quote last year was \$120,000.
- **PARKS & REC**: No report
- **PROJECTS**: Advanced Metering Infrastructure (AMI) project update: Water meter installations 600 of 978 or 60% complete. Electric meters – all but one is communicating with the data collectors.
- **FYI**: 141 utility bills had issues this month.



The next Finance Committee and Council meetings will be held on Monday, February 10th 2025 at 6:30pm/ 7:00pm respectively.
