MINUTES – June 10, 2024
WOODVILLE VILLAGE COUNCIL – REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday June 10, 2024 in Council Chambers 530 Lime St. at 7:00pm. Present at Roll Call: Mayor Ty Tracy, Council Members- Patrick Dunn, Denny Fetzer, Earl Ransom, Joe Riffle, and Tammi Throop. Administration: Village Administrator Tom Brickley, Chief Steve Gilkerson, Solicitor Bob Kuhlman, and Fiscal Officer Barb Runion. Audience: Karen Schepman, Deb Wallace of the Suburban Press, Woodville Township Fire Chief Tim Schnitker, and Linda Knudsen. Council Member Kelly O'Connor was absent.

Mayor Tracy called the meeting to order and led the Pledge to the Flag.

Minutes of the Finance Committee and Special Council meetings on May 28, 2024 were approved as presented.

AUDIENCE PARTICIPATION – Fire Chief Schnitker updated council on the poor condition of the siren located on the roof of the Police Dept/Town Hall. Three of the six speakers are not operable and others have already been replaced on the 30-year-old equipment. To repair would cost over \$9,000 and to replace the siren, it would cost \$20,000 - \$30,000 for a fire siren only. There are no requirements to have the fire/weather sirens by law or fire department regulations. Chief Schnitker has explored grant opportunities, however, currently there are none available. Mayor Tracy will reach out to Sandusky County Commissioners and our Ohio Representative Gary Click to inquire about possible funding options.

Ms. Knudsen reported all planters have been planted for this growing season.

PUBLIC SAFETY- Fetzer thanked the Police Department for the regular informational posts on Facebook.

RECREATION & PARKS DEVELOPMENT – Ransom made a motion to hire the 2024 Pool Lifeguard/Head Guard Staff by name and wage, retroactive to June 3, 2024. (attached) Dunn second. VOTE – Yeas – Ransom, Dunn, Fetzer, Riffle, and Throop. Nays – None. **MOTION CARRIED 5-0**

ADMINISTRATOR – Brickley reported:

- **WATER PLANT**: No report
- **SEWER PLANT**: 1. Have a couple of inspections to do in Phase 5. 2. Phase 6 inspections started today. 3. The lower 40 pump is down again.
- **ELECTRIC DEPT**: Electric has been installed for the Solomon School zone light on W. Main St.
- **STREETS**: Street sweeping and removing tree limbs.
- **PARKS & REC**: Trail Marker Park – the new surface was installed on the basketball court on June 6 & 7.
- **PROJECTS**: 1. Phase 3 Water Line Project – preconstruction meeting was on June 7. Amended schedule is attached. 2. Police Impound Lot Fence – Best of 4 quotes was from Fremont Fence for \$7,141.00.
- **FYI**: 1. Checking into a resin or bronze plaque to replace the one at the Dorothy Keil/Cherry St Bridge. There may be grant funds available for the plaque. 2. The new Woodville Flags were located and will be changed out.

POLICE DEPARTMENT- Chief Gilkerson reported: 1. We have had the use of a speeding trailer that will provide speed data. We will have use of the trailer again in August and September. 2. Looking into obtaining solar-powered radar speed signs. 3. The Department participated in the State annual Click-it-Or-Ticket campaign. 4. Will attend the Commissioners meeting with Mayor Tracy to discuss the rumors regarding the consolidation of the courts. 5. Discussed responsibility of maintaining weeds and vegetation along the right of way in alleys throughout the village. 6. Working on the celebration schedule and Grand Parade Road closures.


