This form must be accompanied by copies of the employee's statement (Form W-2) showing: (1) name and address of employee (2) social security number (3) gross earnings paid before any payroll deductions and (4) amount of additional VILLAGE OF WOODVILLE resident tax withheld. Income Tax withheld for other municipalities must be included on each individual W-2 or attachment to the W-2.

Do NOT include penalties.
